### **WALTER JACKSON A.C.C - 1989**

- Compiled the internal review of Orgreave-'84 onwards
- Schemed SYP's role in the Hillsborough disaster
- Covered under the Police Control Box Table
- Influenced SYP operations until retirement - 1995
- Covered up the truth and became a protected species
- Remembered selectively and lied under oath at inquest

Secured a full police pension in 1995

### **PETER WRIGHT - C.C. AND PRESIDENT OF ACPO**

- Ruled SYP with an iron fist for his "Iron Lady"
- Policed Toxteth '81 and knobbled Orgreave miners - '84
- Sanctioned SYP's role in the Hillsborough Cover-Up
- Resigned on full police pension.

### **PETER HAYES - DEPUTY CHIEF CONSTABLE - '89**

- Involved in a cover-up of Orgreave with A.C.C. Jackson
- Mooted possibility of junior officer appearing to say "I opened the gate"
- Recalled little as a key witness during recent Inquests
- Retired on full police pension in 1993

### **DAVID DUCKENFIELD - CHIEF SUPERINTENDENT**

- Promoted only weeks before the big match
- Screwed up as 'Inexperienced Match Commander'
- Spawned the first big lie during disaster - opening gates
- Elected to 'Worshipful Master' in his lodge - 1990
- Retired on ill-health, thus avoiding disciplinary action - 1991
- Perverted the course of justice for 27 years
- Enjoyed police pension, early retirement and legal aid

### **BRIAN MOLE - CHIEF SUPERINTENDENT - '89**

- Planned the detail of the disastrous SYP operation
- Switched from Match Commander at last minute
- Gloated beforehand that Duckenfield would "fuck it up"
- Fraternised with Duckenfield and others at the Lodge

**BERNARD MURRAY - SUPERINTENDENT - '89**

- Shared responsibilities over Police Control Box fiasco
- Pronounced "Not Guilty" by a jury in prosecution case
- Escaped internal disciplinary action in 1991.

**GRAHAM MOORE - A.C.C. SYP**

- Decided that no officer would face disciplinary action
  - Protected Walter Jackson from disciplinary action
- Promoted to Chief Constable - West Yorkshire Police

8.



**GEOFFREY DEAR - WEST MIDLANDS POLICE - '89**

- Orchestrated the whitewash of the police investigation
  - Displayed wilful blindness to SYP corrupt practice
- Appointed HM Inspector of Constabulary in 1990
- Knighted in 1997
  - Accepted a role of Deputy Lieutenant in 1998
  - Bestowed a title of Vice-Lord Lieutenant of the county
  - Created a Life Peer in 2006
  - Endeared as an Honorary Bencher of Gray's Inn

**LESLIE SHARP - LEAD INVESTIGATOR**

- Seconded to West Mids Investigation of Hillsborough
  - Cushioned the interrogation of WALTER JACKSON
- Knighthed in 1997 upon his retirement from the police

**MERVYN JONES A.C.C. WEST MIDLANDS POLICE**

- Tasked with running the West Mids investigation of SYP
- Ignored SYP's corrupt statement changing process
- Countenanced the perpetuation of the cover-up
- Influenced Coroner Stefan Popper unduly over alcohol

11.



**STANLEY BEECHEY - WEST MIDLANDS POLICE**

- Headed up the corrupt Serious Crime Squad in WMP
- Commanded the squad when it was forced to disband
- Fabricated evidence and altered statements
- Framed innocent men in proven miscarriage of justice
- Allowed to influence the Coroner Stefan Popper

### **JULIA APPLETON - RETIRED WEST MIDS POLICE**

- Allegedly bullied Special Constable Debra Martin
- Visited Debra Martin at her home on 3 or 4 occasions
- Exerted undue pressure on witness to alter statement
- Denied the accusations made against her at inquest

### **RICHARD WELLS - CHIEF CONSTABLE SYP - '91**

- Retained the services of Walter Jackson as his A.C.C.
- Fast-tracked officers like Bettison and Hogan-Howe
- Opposed the influence of Freemasonry
- Commented on Inspector Calvert's whistle-blowing
- Quoted from Edmund Burke in 1995.
- Called for police officers to be prosecuted

### **DAN CROMPTON - H.M.I.C.**

- Criticised the families over Hillsborough as HMIC
- Described them as vindictive and cruel over Bettison
- Assessed Bettison's posting to Merseyside Police
- Defended the Chief Constable's appointment there
- Knighted in 2005

### **DAVID CROMPTON - CHIEF CONSTABLE SYP**

- Awarded QPM for community work post 7/7 Bombings
- Appointed Chief Constable of SYP in 2012
- Reprimanded over Hillsborough comments in 2012
- Announced early retirement prior to Inquest verdict
- Protected the "Walter Jackson" Control Box Incident
- Suspended over Inquest conduct of SYP in 2016

### **BERNARD HOGAN-HOWE - NATION'S TOP COP**

- Criticised for his role on the day at Hillsborough
- Transferred to Merseyside Police as A.C.C. - 1997
- Declared a Hillsboro' Cover-Up could not happen today
- Appointed Chief Constable of Merseyside - 2007
- Metropolitan Police Commissioner - 2011 to present
- Knighted - 2013

### **IAN BLAIR - NATION'S FORMER TOP COP**

- Controlled the orchestration of London Bombings '05
- Knighted - 2008
- Given a cross bench life peerage - 2010
- Blasted SYP over Hillsborough - hypocrite - 2012
- Befriended Professor Phil Scraton Hillsborough - 2016

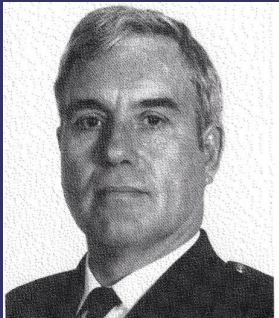


### **NORMAN BETTISON - THE RISE AND FALL**

- Suspected of running the Hillsborough "Black-Ops" Unit
- Promoted to Superintendent within SYP - Oct. 1989
- Appointed an Assistant Chief Constable in WYP - 1993
- Chief Constable Merseyside Police amidst protests - '98
- Awarded the Queen's Police Medal - 2000
- Given QE2 Golden Jubilee Medal - 2002
- Retired to become Chief Executive of Centrex in 2005
- Knighted - 2006
- Rejoined police as Chief Constable WYP - 2007
- Given QE2 Diamond Jubilee Medal - 2012
- Accused of a multitude of serious criminal acts
- Resigned from WYP with immediate effect - 2012
- Referred to the IPCC over Stephen Lawrence Enquiry

### **TERRY WAIN - CHIEF SUPERINTENDENT**

- Produced the infamous "Wain Report"
- Denied his report deliberately attempted to blame fans
- Admitted the report was wrong and favoured police
- Defended Senior Officers in his report
- Alleged fans were violent and influenced by alcohol

### **A.C.C. STUART ANDERSON**

- Recommended C/Supt. Mole be moved to Barnsley
- Defended this decision at the Second Inquest
- Briefed officers afterwards - not to blame themselves
- Blamed drunk ticket-less fans instead
- Linked to Orgreave, and a Freemason up until 1985

### **DONALD DENTON - CHIEF SUPERINTENDENT**

- Oversaw the changing of officers' accounts - 1989
- Suggested amendments to accounts - 1989
- Admitted amendments may have impeded Inquiry '89
- Liaised with West Midlands Police and Peter Metcalfe
- Found to have lied at the Stuart Smith Scrutiny

### **JAMES SHARPLES, CHIEF CONSTABLE MERSEYSIDE**

- Attended match in the Directors Box - 1989
  - Visited Police Control Box several times at key times
  - Irked the families for his criticism of the fans
  - Praised conduct of senior officers from SYP on the day
- QPM and Knighted in 1996

### **ROGER MARSHALL - SUPERINTENDENT**

- Supervised the operations outside Leppings Lane
- Expressed profound regret for not asking K.O. delay
- Demanded gates be opened to save lives outside
- Visited the Police Control Box at 4pm
- Described the officers inside being in a state of shock
- Admitted that Duckenfield had told a "wicked lie"
- Accompanied Duckenfield and Jackson to Police HQ
- Suspected that Senior Command wanted Marshall to carry the can initially

### **ROGER GREENWOOD - SUPERINTENDENT**

- Stopped the match at 3:07p.m. by running on pitch
- Expected the Control Room to take control soon after
- Stated that he felt as if dealing with the disaster alone
- Sobbed in the witness box about his recollections

### **JOHN NESBIT - CHIEF SUPERINTENDENT**

- Described police handling as "chaotic" with a complete lack of organisation
- Alleged to have taken officers to a pub gathering to get story straight a few days after Hillsborough
- Alleged to have said: "We have all got to get our stories straight or a lot of senior officers' heads will roll."



- After retirement on full pension employed as Safety Officer at Hillsborough Stadium

### **DETECTIVE CHIEF SUPERINTENDENT ADDIS**

- HIP report states that DCS Addis could not get into the Control Box because of “Fireman stuck in the door”.
- Addis, under questioning, said he had arrived at Hillsborough and talked to Jackson at 4pm but repeatedly said he could not remember what Jackson had told him; Addis said he did not think he had even asked Jackson for an initial view of what had caused the unfolding disaster.
- Addis also denied that he had instructed his CID officers in the gymnasium to ask relatives about alcohol, but his account did furnish the families with an explanation for how they were questioned.

### **BOB PURDY - AN INSPECTOR ON DUTY**

- Regretted calling fans “animals”
- Described Roger Marshall as “looking perplexed”
- Shouted at officers on the pitch who were mesmerised
- Failed to object to his statement being changed

Promoted to Temporary ACC before retirement

### **IAN DAINES - FORMER A.C.C.**

- Patronised families in 2000, after Hooper's retrial ban
- Labelled whistle-blower Inspector Calvert as “naïve”
- Stated nothing more could be learnt after Stuart-Smith
- Expressed his hope for the families to “move-on”
- Retired on full ACPO police pension

### **ANDY HOLT - FORMER DEPUTY CHIEF CONSTABLE**

- Linked with the “Old Trafford Bomb Hoax” - 2004
- Helped cover-up the “Bogus Terror Threat” construct
- Coined the SYP mantra “Enabling The One Truth”
- Attended the Hillsborough Inquests with Hayley Court

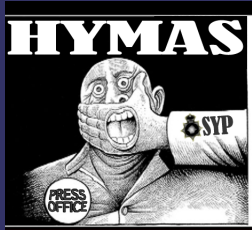

### **SUPERINTENDENT TONY PRATT - SYP**

- Gates opened at Barnsley v Stoke on 31<sup>st</sup> Jan. 1989
- Linked with Barnsley FC “dummy run” of Leppings Lane
- Disciplined press office support staff over Hillsborough

**ANDY HYMAS - FORMER SYP PRESS OFFICER**

- Witnessed “Jackson Under The Table” Incident
- Omitted any mention of it in his statement – 1989
- Declared himself as honest in 2016
- Concerned about being in papers

**SGT GODDARD - POLICE CONTROL BOX**

- Located in the Police Control Room all day
- Statement of a conversation heard was later removed
- Minimalist statement after 3:40pm
- Concealed the truth about ACC Walter Jackson incident

**TREVOR BICHARD - POLICE CONTROL BOX**

- Located in the Police Control Room all day
- Minimalist statement after 3:40pm
- Described Duckenfield as “A fish out of water”
- Concealed the truth about ACC Walter Jackson incident

**P.C. MIKE RYAN**

- Located in the Police Control Room all day
- Claimed he could only remember seeing JACKSON once
- Concealed the truth about ACC Walter Jackson incident

**PAUL MIDDUP - POLICE FEDERATION**

- Appeared on mainstream media after the event
- Unleashed outlandish allegations against the fans
- Used as a mouthpiece for Chief Constable Peter Wright
- Remained in denial. Never checked veracity of source.

**GORDON SYKES - OFFICER ON DUTY**

- Described Leppings Lane as a death trap
- Shared unfounded claim of fans pickpocketing the dead
- Shared allegations with Police Federation colleagues
- Linked to Duckenfield and Irvine Patnick at Niagara
- Agreed the claims were false during recent Inquest

**RICK NAYLOR - (NARPO) RETIRED POLICE OFFICERS**

- Urged 80's police officers to be “proud” of their work
- Infuriated families in aftermath of recent verdict
- Wished for clock to be turned back
- Showed empathy for police officers who did good jobs

### **RACHEL CERFONTYNE - IPCC - 2013**

- Involved with the Mark Duggan cover-up
- IPCC deemed "Not Fit For Purpose" Keith Vaz.
- Plans to pursue uncooperative witnesses
- "National legislation means that no investigation has the power to force witnesses, whether they are police officers or members of the public, to give accounts."

### **JON STODDART - CRIMINAL INVESTIGATION**

- Operation Resolve Established 2012
- 220 full time staff, zero arrests
- Zero prosecutions
- FREEMASON FREE ZONE
- Plan to provide evidence to the CPS by end of 2016
- Sent information about WALTER JACKSON
- Resigned owing to "Ill-Health" - September 2016

### **GERRY DONNELLAN - OPERATION RESOLVE**

- Deputy Officer in overall Command
- Acknowledged receipt of information about JACKSON
- Reassured the public over Jon Stoddart's departure

### **TOM WINSOR - HMIC**

- Declared the suspension of David Crompton unfair
- Provoked anger with rank and file police officers
- Wore a police uniform at ceremony - never been a cop
- G4S links and knighted in 2015

### **CLIVE DAVIS - FORMER SUPERINTENDENT**

- Testified and accused Norman Bettison of malpractice

- Compiled a report about Hillsborough - suppressed
- Claimed WMP demanded he stop putting in reports
- Provided startling revelations on Channel 4 News
- Revealed insight about Duckenfield, Mole and Masons
- Testified against Duckenfield at Warrington Inquests

### **CLIVE CALVERT - POLICE INSPECTOR**

- Compiled critical internal reports about Leppings Lane
- Forewarned senior managers about Leppings Lane
- Alerted C.C. Richard Wells of police statement changes
- Labelled as naïve by ACC Daines - Stuart Smith Inquiry

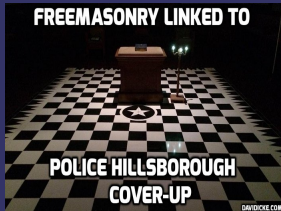

- Worked in Communications Dept. of SYP - 1989

### **HAYLEY COURT - PRESS OFFICER**



- Employed as press officer for Hillsborough Inquests '15
- Pressured into being a spin-doctor for the police
- "Your job is to round up the media at the end of the day and tell them: 'This is the line.'"
- "I took that as being told my job was to tell the media what they would be reporting, which isn't ethical or even possible to do."
- Felt duty-bound to expose SYP's media strategy
- Blew the whistle after completion of the inquests

### **MARGARET THATCHER**

- Intoxicated Liverpool over the Toxteth Riots - 1981
- Defeated the Miners of South Yorkshire - 1984
- Berated Liverpool over Heysel Disaster - 1985
- Resolved to overhaul Football's tarnished image
- Enabled a systematic cover-up of Hillsborough to occur
- Invoked secret files over Hillsborough
- Endorsed football as a commercial enterprise
- Bestowed with the Member of the Order of Merit - 1990
- Granted Life Peerage - 1992
- Awarded the UK's highest order of Chivalry - 1995
- Denis was created a Baronet - 1990

### **DENIS THATCHER**

Bruce Anderson noted one case where Denis Thatcher had influenced policy: "Football, in his view, was run by vulgarian spivs in astrakhan coats and gold jewellery... So he helped to persuade his wife to regulate the misbehaviour of soccer crowds. This did not work - yet it might well have been in football's best interests."

- Besmirched Liverpool Supporters - outlandish lies
- Assisted Thatcher and co. in post Hillsborough show

- Promoted to a cabinet whip - 1989
- Embraced Freemasonry
- Knighted in 1994
- Exposed within the HIP Report - 2012
- Apologised belatedly / died shortly afterwards - 2012



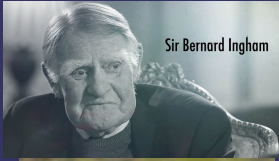

### **THERESA MAY - CURRENT NEW PRIME MINISTER**

- Praised arguably prematurely by Margaret Aspinall
- Compared favourably with Thatcher by HFSG
- Stirred up the Commons with a speech on Hillsborough

**BERNARD INGHAM - THATCHER'S PRESS SECRETARY**

- Declared "Enough is Enough" after Heysel - 1985
- Inspected Hillsborough alongside Thatcher afterwards
- Besmirched Liverpool Supporters - outlandish lies
- Blamed the fans unjustifiably
- **Knighted - 1990**
- Advocated compensation for the police - 1996
- Refused repeatedly to apologise over Hillsborough

**DOUGLAS HURD - TORY HOME SECRETARY**

- Helped establish a "Hooliganism War Cabinet" - 1980's
- Accompanied Thatcher to visit Hillsborough aftermath
- Briefed with Thatcher by C.C. Peter Wright - no record
- Shaped the Terms of Reference for the Taylor Report
- Pushed for a Membership Scheme for Spectators
- **Created Baron Hurd of Westwell - 1997**

**COLIN MOYNIHAN - MINISTER FOR SPORT**

- Alerted to perils of the Leppings Lane End - 1988
- Spearheaded Thatcher's visit to Sheffield
- Hosted by Irvine Patnick on the evening
- Declined to comment about IPCC investigations
- Advocated radical solutions pre-Taylor report
- **Elected as Hereditary Peer in the Upper House -1997**
- Involved with Haberdashers' Company - Masonic

**MICHAEL SHERSBY - TORY MP**

- Liaised with the Police Federation over Hillsborough
- Promoted Norman Bettison's video before parliament
- "Police behaved magnificently on this occasion"
- Involved in a counter attack after Interim Taylor
- Claimed PC Middup vindicated

**Knighted - 1995**

### **CHARLES POWELL - TORY CABINET MINISTER**

- Associated with Thatcher's visit to Hillsborough
- Accused of briefing Trevor Kavanagh - The Sun
- Denied that he briefed Trevor Kavanagh - The Sun
- Knighted Order of St. Michael and St. George - 1990
- Created a Life Peer - 2000

### **JACK STRAW - FORMER HOME SECRETARY**

- Failed to order a proper inquiry in 1997
- Duped the families with the Stuart Smith Scrutiny
- Exposed as dishonest in cash for access scandal -2015

### **TONY BLAIR - FORMER PRIME MINISTER**



- Supported by Rupert Murdoch to get into power
- Endorsed PEL Stadium Seats after Hillsborough
- Employed Charles Powell's brother, Jonathan as his Labour Party Senior Adviser
- Frightened to offend Murdoch with a proper Hillsborough Inquiry
- Protected from prosecution for war crimes

Tony Blair failed to order a full inquiry into the Hillsborough disaster to avoid offending Rupert Murdoch and News International, the publisher of the Sun newspaper, Andy Burnham has suggested. Burnham claims Blair did Murdoch a favour.

Andy Burnham said he was told not to pursue his demand for an official investigation when serving under Mr Blair. He said there seemed to be a decision by the Blair administration on Hillsborough to "leave it alone".

"That was the wrong decision and allowed a major injustice to remain in place for 11 to 12 years," he said.

## **Blair on inquest: What's the point?**

**TONY BLAIR** tried to pour cold water on the idea of reopening an investigation into the disaster shortly after coming to power, according to the report.

In 1997, following pressure after the televising of Jimmy McGovern's film Hillsborough, then home secretary Jack Straw advocated appointing an independent figure to re-examine the inquest evidence.

In a note 'apparently' written by Mr Blair in response to the suggestion, the then Prime Minister remarked: 'Why? What is the point?' In the end, a report commissioned by Lord Justice Stuart-Smith concluded there was no evidence to reopen the inquests.

### **BORIS JOHNSON - POLITICIAN / FORMER MAYOR OF LONDON**

The extreme reaction to Mr Bigley's murder is fed by the fact that he was a Liverpudlian. Liverpool is a handsome city with a tribal sense of community. A combination of economic misfortune – its docks were, fundamentally, on the wrong side of England when Britain entered what is now the European Union – and an excessive predilection for welfarism have created a peculiar, and deeply unattractive, psyche among many Liverpudlians. They see themselves whenever possible as victims, and resent their victim status; yet at the same time they wallow in it. Part of this flawed psychological state is that they cannot accept that they might have made any contribution to their misfortunes, but seek rather to blame someone else for it, thereby deepening their sense of shared tribal grievance against the rest of society. The deaths of more than 50 Liverpool football supporters at Hillsborough in 1989 was undeniably a greater tragedy than the single death, however horrible, of Mr Bigley; but that is no excuse for Liverpool's failure to acknowledge, even to this day, the part played in the disaster by drunken fans at the back of the crowd who mindlessly tried to fight their way into the ground that Saturday afternoon. The police became a convenient scapegoat, and the Sun newspaper a whipping-boy for daring, albeit in a tasteless fashion, to hint at the wider causes of the incident...

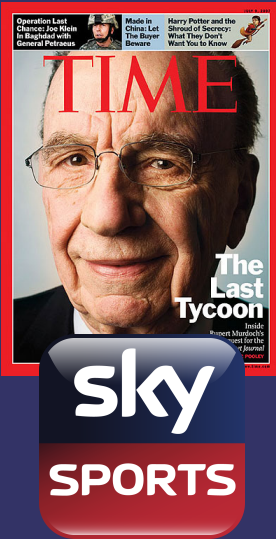

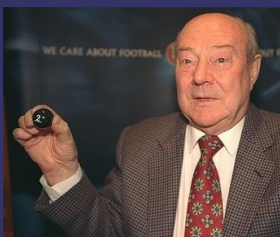
### **ALAN SUGAR - TYCOON / FOOTBALL CHAIRMAN**

- Benefited from selling Sky TV Satellite dishes
- Knighted in 2000 and Created a Life Peer in 2009

### **BERT MILLICHIP - FOOTBALL ASSOCIATION**

- Associated with Thatcher's visit to Hillsborough - 1989
- Served as a Trustee of the Football Trust
- Donated £2.5m to the Hillsborough fund

- Knighted in 1991, PEL Stadium Seating - 1996
- Opined about not taking fencing down

### **TED CROKER - FOOTBALL ASSOCIATION**

- Appointed son-in-law as Sales Director - 1990

From his raised seat in the makeshift courtroom in a previously empty Warrington office block, Goldring noted at the end, in his characteristically formal manner, how "agonisingly difficult" it had been for the families. He acknowledged, with some grace but profound understatement: "I know, on occasion, you have not agreed with my decisions."

The truth is that during many traumatic legal battles - which could not be reported until afterwards because the jury was absent - the families and their lawyers bitterly challenged Goldring's rulings.
