Dear Andy,

I hope you are well and in good spirit.

This is Tony Farrell writing from Ireland. In the light of the recent verdict of the inquests in Warrington, the purpose of this letter is three-fold and is as follows:

1. To explain our current position with respect to the story you told me in 2009 about Walter Jackson;
2. To request your assistance to help us break open the still hidden truth about the Hillsborough Disaster;
3. To outline the steps we intend to take, depending on how you respond to our request.

#### OUR CURRENT POSITION

By 'our' current position, I am referring to the position of Muad'Dib and me. While you know a bit about me, allow me to explain briefly who Muad'Dib is, as you may not know about Him. Muad'Dib is perhaps best known as an international film-maker. Muad'Dib produced the sensational 7/7 Ripple Effect 1 and 2 films. The latter of which is enclosed on a DVD for your information. I urge you to watch it. Muad'Dib is also known as JAH and He is taking much interest in your story, as told to me. JAH wants to help you, to help Him unlock the hidden truth behind the Hillsborough Disaster and the Walter Jackson cover-up. We know that you could play a pivotal part in exposing the truth about this, at least in part. From my own experiences in South Yorkshire Police, I can appreciate how difficult the position must have been back in 1989, when confronted by Senior Police Officers hell-bent on deceiving the nation, with their corrupt evidence and perverted version of truth. It is abundantly clear to us that Walter Jackson has been, and continues to be, protected by the powers-that-be. We know the corruption extends well beyond South Yorkshire Police. We realise that you probably

know that, too. As things stand, your own witness statement, written back in 1989, if it remains uncorrected, helps to further 'pervert the course of justice', rather than elicit the truth. From what I know of you, I very much doubt that that is a position which gives you any comfort, or peace of mind. This subject is of vital importance, and we want to help you tell the truth about, not just what happened during that day with Walter Jackson, but also what subsequently led you to produce a witness statement, so completely at odds to the story which you subsequently personally shared with me back in 2009.

We believe that your story, if told truthfully, sooner rather than later, would be very favourably received by the families and supporters of the 96, and the world at large. I know for one, that Trevor Hicks, who lost his two young daughters, Vicki and Sarah, in the tragedy, would appreciate the truth being told by you. Trevor filed a complaint directly against Walter Jackson in 1989, which was not upheld because of your acquiescence, and so he would very much appreciate you coming clean on this, as he is painfully aware of the details of your story, that you told me twenty years later. Justice was denied all that time ago.

Please don't, by your own ongoing silence, assist justice to be denied for any longer. While we appreciate that you are obviously not one for seeking any limelight here, it remains abundantly clear to us that you have 'a duty of care' to tell the families and that world at large, the truth on this. If you do what we suggest, thousands, if not millions of people will come to see you as far more of a hero, than any villain in the piece.

For that to happen though, the nation needs to clearly understand fully the kind of pressures exerted on you in 1989, and upon learning of that, they will look more favourably on any of your past mistakes, so long as you act decisively and expose the truth without further delay.

Conversely, it will be unforgivable, if you fail to act promptly for the side of good here, while you still can. Now is simply not the time to bury your head in the sand and 'hedge your bets' in an effort to see which way the forthcoming criminal trial unfolds. The nation needs a whistle-blower, and it needs one now. With respect, you must make sure that that whistle-blower is you, and not someone else, who beats you to it.

For our part, we will not stop until the whole truth is exposed, and we see the real culprits, jailed. To that end, Muad'Dib is making a special Hillsborough Ripple Effect documentary film.

This documentary will reveal in the starkest terms possible, the real motives behind the disaster and the cover-up. His film will be sent out far and wide, and will be made available to each of the families of the 96. We don't want to label you as one of the culprits here, unless you leave us with no other option. If you don't come clean and do it soon, you will be forever categorised as one of the main culprits for the cover-up.

## 2. HOW YOU CAN HELP

Please consider this request very carefully. Muad'Dib, Who is currently preparing His film entitled: 'The Hillsborough Ripple Effect', wants to interview you, with my help, as part of the wider project, so that your critically important story about Walter Jackson, becomes known to the world at large. It is vitally important for it to be done like this, in order to prevent further obfuscation and cover-up, by the utterly corrupt establishment.

Muad'Dib wants you to tell your side of the story, and why you wrote a less than truthful statement, and who pressured you to do so, so that the audience will empathise with you and the difficult position you were put in, and see how you are now wanting to do the right thing and clear your conscience, having finally found the courage to tell the truth.

We know that this will be in your very best interests for it to be done like this. We are also asking Gillian Radcliffe, if she is willing to assist us, in order to hopefully, make you feel more at ease with this highly recommended course of action. Her input is desirable, but not essential. Your input however, is essential.

We would be willing to conduct such an interview in the Sheffield area, but equally we could offer you Ireland as an alternative venue, whichever is preferable for you. We want you to come across in the very best possible light, and give you every opportunity to make a full and frank confession before the camera.

If you co-operate with us on this, Muad'Dib will ensure that the film gets produced and circulated in such a way, as to engender fairness to all, and give appropriate emphasis concerning your exonerating circumstances.

### 3. WHAT IF YOU ARE UNWILLING TO COOPERATE

If you are unwilling to assist us in exposing the truth in this way, Muad'Dib will continue to make His documentary, regardless. However, before that happens, I, with JAH's full support and backing, will take all necessary steps to publicise widely my own short film, which I have already made. My film as opposed to Muad'Dib's documentary is entitled, 'Hillsborough - The Sixty-Four-Thousand-Dollar Question: Why are T.H.E.Y. protecting Jackson?'

You won't be surprised to learn that you feature in it. A copy of my short film is enclosed on a DVD. It has not yet been placed in the public domain, because I wanted to give you every opportunity to watch it, and in so doing help determine for us, our next step. In the event that you do not co-operate with us on such grave and serious matters of truth, we will be sending my film out to all the families of the 96 and their solicitors, and we will not stop in our efforts to promote this film as far and wide as we possibly can.

If we do not hear from you by the 7th July 2016, we will publish. Furthermore, Muad'Dib's subsequent Hillsborough Ripple Effect film, which I have already mentioned, is under preparation, and that documentary will reflect accurately your response to our offer to help you expose the truth.

Respectfully, I suggest that shunning JAH here will be a very big mistake indeed, and will be tantamount to you further countenancing the perpetuation of the monstrous cover-up of the truth behind the Hillsborough Disaster.

We urge you not to allow yourself to be left in that unenviable position, for any longer.

#### SUMMARY

We mean you no harm here, and sincerely, JAH / Muad'Dib has your very best interests at heart, but you must do the right and proper thing. Truth will prevail, come what may, it always does, but we want you to redeem yourself and play a vital part in bringing the truth one huge step nearer to home.

*Matthew 10:26 Fear them not therefore: for there is nothing covered, that shall not be revealed; and hid, that shall not be known.*

For the last twenty-seven years, you have lived a lie with this, while many others have greatly suffered from not knowing the truth and others have prospered from their evil deeds. So we ask you now to take this one-off golden opportunity, to clear your conscience and make a brave, correct and righteous decision. You owe no loyalty whatsoever to the corrupt personnel who pressured you into lying for the organisation back in the class of '89. Put truth and the interests of the victims before the ongoing protection of our long-since discredited former employers, and put the general well-being of the police service and the nation first, for a change. Realise this. If you do what we advise, you will in all likelihood come to be seen as a hero to millions.

I want to end this letter with a final plea to you.

Over time, I have made it my duty to talk to many different family members and supporters of the 96. In particular, I have spoken at length to Trevor Hicks, Margaret Aspinall, Barry Devonside and met with Sheila Coleman of the Hillsborough Justice Campaign. I have written to people like Andy Burnham MP and Steve Rotherham MP and I have corresponded with various solicitors and barristers, including QC Peter Weatherby, who represents twenty-two of the families.

While I was not at Hillsborough on the day, I do have an unusual vantage point. In 2010, I stood up for truth before the Chief Constable who wanted me to lie, on an issue even worse than Hillsborough. I am thankful that I did so. In my moment of decision, frightened though I was back then, I made the correct choice, and I want you to do likewise, now.

Any fear will subside, if you do the correct thing. I think it fairly safe to say that I can empathise with how you must be feeling. These days, I am utterly convinced there was a higher purpose involved in why you off-loaded your story to me, and probably me alone, back in April 2009.

I recall the time Richard Wells quoted from Edmund Burke.

“The Only Thing Necessary For The Triumph of Evil, Is For Good Men To Do Nothing.”

Like me, your former manager and good friend Gillian Radcliffe, welcomed the fact that Chief Constable Richard Wells used that particular quote in his annual report in 1995.

Think well on the meaning of that quote, and please give our request and offer to help you, very careful consideration.
