***Dear Mr. Crompton,***

***Thank you for the reply, and likewise best wishes to you and all at South Yorkshire Police in 2014.***

***By way of a quick update, following a hearing before District Judge Buxton, in which I was present as a witness, the property I am currently staying in by invitation is to be repossessed by HSBC Bank PLC. The court order takes effect from 9th January 2014. The District Judge did not grant permission for an appeal. This morning, an Appellant's Notice of Appeal was handed in to the Circuit Judge in Sheffield County Court. This was a request for permission to Appeal to the higher judge.***

***As explained in my last letter sent to you, I have no intention of vacating the property and handing it over to a criminal organisation like HSBC Bank Plc. I guess that will potentially make me a squatter in the eyes of HSBC Bank Plc in seven days time and I am mindful that it potentially makes me liable for arrest from South Yorkshire Police as squatting is a criminal offence.***

***For your information, I am enclosing the Grounds for Appeal. This was filed this morning alongside the Appellant's notice, skeleton argument and full bundle.***

***Finally, I am aware that it will be a challenging year for my former employers, particularly***

*over Hillsborough. This year will mark the 25th anniversary and I am certain the people of Merseyside will be having a special memorial service at the Anfield Stadium. I have no idea how feasible this is, but it crossed my mind that it might be a magnanimous gesture if you as the Chief Constable could somehow be present at the service to express sincere regret on behalf of the force's role over the last quarter of a century. As you are probably aware, last April/May I sent a hyper-linked email of Bill Kenwright's speech at the 24<sup>th</sup> Memorial Service to the email addresses of about 500 police officers in your force because I thought it might do some good for your officers to reflect on things from their vantage point.*

*Anyway, it's just a thought given I have seen it from both sides. Perhaps Mr. Bill Kenwright might be the person to facilitate something to that effect if you see any merit in my suggestion.*
