Dear David,

I hope this finds you well, in good spirit and having a good day.

Yesterday, as I wrote this, it was the 17th May. Now that might not mean much to you, but it certainly meant something to Ms. Seven, the lady to whom I introduced you on 15th April. Before a camera, you gave her an undertaking to provide a considered response to our joint 240 page report. The only response we've had so far from your force, is my arrest and charge. This comes from a force which aims to be the best force in the country.

Exactly two years ago to the day yesterday (17th May), two of Ms. Seven's friends died unexpectedly in very mysterious circumstances. Both deaths were deeply suspicious and were briefly covered in our joint report, sent to you personally, as far back as 5th July 2013. To the present day, we still have not had a response from you with respect to this report.

In the national news yesterday and the day before, were various headlines about Steve Williams from the police. Williams was making headlines for all the wrong reasons. This Steve Williams however, was not the one on a terror drill exercise down in London on 7th July 2005. No it was plainly not my former boss, but rather it was the former head of the

Police Federation. Steve Williams' crime was allegedly institutional bullying.

So yet again, here we have yet another strange circumstantial sign. After the 17th May 2012, I only became re-acquainted with Ms. Seven when I was actually in the process of seeking out a photograph of Steve Williams my former boss on the elevated grassy bank opposite the Professional Standards Unit building at Chapeltown. This pursuit came from a request from Muad'Dib / JAH days prior to the release of His 7/7 Ripple Effect II Film. We had hoped to show Steve Williams in the film. While I may have failed to catch Steve Williams on camera, instead, I got a phone call, completely out of the blue from Ms. Seven, who was at that time still a relative stranger to me.

You are probably aware that on 9th May 2014, I was arrested (very gently) and charged (somewhat reluctantly) by PC 807 Leo Hawker. The charge was for resisting John Griffith, an officer of court engaged in executing process issued by the High Court, for the purposes of enforcing a judgement or order for the recovery of or delivery of possession of the premises located near Nick Clegg's constituency offices in Sheffield. I was remanded in custody overnight, not having an address for bail.

At a hearing the next morning (10th May), before the Magistrate, I pleaded "Not Guilty" to the charge brought on by Hawker's insipid actions. As you are all too aware, there's an abundance of mitigating circumstances in my case. Yet still you and your chums all maintain your wall of silence. My interim request for a meeting to brief you on Ms. Seven's case, seems once again, to have fallen on deaf ears.

Following my arrest, in an evening of conviviality last Tuesday, I again spoke before the camera in a back-room of a city-centre pub in Sheffield. This was on the evening 13th May 2014. Inevitably, the name of David Crompton, Chief Constable of South Yorkshire Police cropped up quite a lot, and extensive reference was made to your talk on corruption on 4th February at the Greystones.

PC Hawker bailed out in his moment of choice, just like you did over Buxton, Bellamy and Babbington, the three district judges you have abjectly failed to arrest for committing serious criminal offences.

All this has been under your watch over the twelve months, while you sit back and seemingly do nothing, whereupon I lose my own home and have now been turfed out from another one.

Believe it or not, my offer to meet with you still stands. As I stated in my last communication, Muad'Dib / JAH would also like to meet with you too. It was at His special invitation that I was staying at the house from which the "Clegg-gate" eviction occurred.

Meanwhile, while you dwell upon my request, here's a parable I thought apt to share with you and also PC Hawker, the arresting officer.

THE PARABLE OF THE CHIEF CONSTABLE AND THE GRATEFUL MOTHER INSPIRED BY LUKE 18:1-8.

In a certain city, by a certain lake, a certain drowning child's screams can be heard from afar. Surrounding the lake, is a certain notice which says:

"Keep Out! Trespassers Will be Prosecuted!"

And will you be sending representation to my Jimmy's funeral on Monday, please Sir?"

"Of course, I will respond in person. I will speedily make re-arrangements to be in attendance myself," replies a re-assuring Chief Constable.

"And when the Chief Constable attends at that child's funeral and sees a Mother weeping, shall he then find comfort in his Queen's Police Medal?"
