Dear David,

I hope this finds you well, in good spirit and having a good day.

Attending at the Sheffield Magistrates court on 24th July, the court administrator told me that the prosecution case against me had been dropped by the CPS. This followed my arrest on 9th May for resisting a bailiff. The result of this arrest carried out by PC 807 Hawker was that, for a second time in 15 months, thanks largely to South Yorkshire Police, I was made homeless. At all stages, you were kept informed of developments and made aware of the case, and my valid reasons for the stance, yet in spite of this, you allowed this arrest to happen, to my repeated detriment. All that your force has done here is to further assist the perpetuation of the unlawful actions of the "banksters", by backing their "bag-boy bailiffs" and shameful courts. Thus undoubtedly making you an accessory to their crimes.

I wish you to know that I have in the first instance lodged a formal complaint against the arresting officer, PC 807 Leo Hawker, for what I consider to be a wrongful and an unlawful arrest. This arrest and the associated events of 15th April 2014, as with so many other things I

could mention, do not reflect well on your force. Sgt. Chris Moran took down details of my complaint.

Working with JAH/Muad'Dib, we are about to unleash material which has been a full year in the making. This will bring you and your force under the public spotlight in ways you will not be anticipating. Muad'Dib is much more than a capable film-maker whose previous films, 7/7 Ripple Effect, 7/7 Ripple Effect 2, and the Nazi Banksters' Crimes Ripple Effect have made quite an impact. The potential for us to expose you is a real and present danger for you, and time is running out for you to mend your corrupt and criminal ways.

Sadly, owing to your entrenched attitude of cognitive-dissonance and being in denial of the truth, our series of new films will not be pulling any punches in the new releases, as you have all but ignored our repeated efforts to bring to your attention serious and organised criminality on a massive scale. Seldom, if ever, do you afford me the courtesy of any reply whatsoever on these serious matters. Well, after four years of being on the receiving end of your "injustice without courage", the time is fast approaching for me to strike back.

Our previous offers to meet with you and your Senior Command Team have fallen on deaf ears and your belated response to Ms. Seven's request for help was lamentable, in my opinion. I have informed you previously that I have very serious intelligence to impart to you. Yet all I get from you and your force is either stonewalling and silence, or attacks for telling the Truth. For a force that has aspirations to be the best force in the country, you sure as hell have a contradictory and very strange way of going about it.

The material I have spent a full year working on, will be released publicly in the next four / five weeks. Before it is released, I wanted to offer you one last opportunity to meet with JAH and myself to discuss a meaningful way of translating your false rhetoric into truthful action, so that you transform your force into the best force in the country, at one fell swoop. This is my last offer.
