We appeal against the opinion of the inner house on the 28<sup>th</sup> October 2016, in the matter of the Scottish Parliamentary corporate Body v's Richard McFarlane and Maureen McLeod (Respondents) (92016) CSIH 81/15 for Orders under section 46 of the Court of Session Act 1988.

#### **GROUNDS FOR APPEAL**

### In the name of God/Allah Most Gracious, Most Merciful

We motion the court that our appeal to the Supreme Court be granted on the following grounds:-

### 1.

Leonna Dorrian, who took the lead in the appeal, should have recused herself, because of her ties to Brodies, who were representing the SPCB, being a conflict of interest.

The Authority for this dispute is The Holy Bible book of Ezekiel chapter 21 verses 26-27 and the four overturns of the Throne of David - the British-Israel Throne – Jacob's Pillar Stone - the Stone of Destiny.

Ezekiel 21:26 Thus saith the Lord "I AM"; Remove the diadem (sovereignty), and take off the crown: this [shall] not [be] the same: exalt [him that is] low (Line of Zarah), and abase [him that is] high (Line of Pharez). 21:27 I will overturn, overturn, overturn, it: and it shall be no [more], [overturned] UNTIL he come whose Right it is; and I will give it [him - Shiloh (Gen. 49:10)].

Genesis 49:10 The sceptre shall not depart from Judah [to Joseph], nor a law-giver from between his feet, **UNTIL** Shiloh comes [from Joseph-Ephraim v 22-24]; and unto him [shall] the gathering of the people [be]. 49:22 Joseph [is] a fruitful bough, [even] a fruitful bough by a well; [whose] branches run over the wall: 49:23 The archers have sorely grieved him, and shot [at

him], and hated him:

49:24 But his bow abode in strength, and the arms of his hands were made strong by the hands of the mighty [God]

of Jacob; (from **THERE** [is] The Shepherd, The [Corner] Stone of Israel:)(1 Cor. 10:4; Daniel 2:34-5; 45)

King George the 6th was **distraught**, because he **KNEW** that the removal of the Stone of Destiny from Westminster Abbey, by those four Scots' heroes; Matheson, Hamilton, Vernon and Stewart, with God's help; without which they could not possibly have succeeded in taking it; meant the end of George the 6th's dynasty.

The Archbishop of Canterbury screamed at the nation that sacrilege had been committed, but king George and his family knew the Bible prophecies about the Stone of Destiny / Jacob's Pillar Stone, which is the real British-Israel Throne and Throne of David, better than the archbishop, who obviously did not realise the significance of the removal.

George the 6<sup>th</sup> and his family KNEW that the fourth and final overturn of the Stone-Throne to Shiloh-Christ, its Rightful and Lawful owner, had been made, and that his daughter Elizabeth and her heirs were no longer royalty, and could now **never** be lawfully crowned.

Elizabeth and her dad king George knew, with the removal of the Stone, **on Christmas Day**, that she could not be lawfully crowned, because, it being removed on Christmas Day **confirmed** the prophesied fourth and final overturn, and that Christ had already come again, and that one day Christ would make His presence and new identity known, and claim His Rightful Throne, which He did in 1988. He did it by issuing a High Court Writ, demanding that the UK Parliament acknowledge Him as King, which they foolishly rejected; by quoting their fraudulent legislation to Him, as justification for their rejection of His rightful claim.

We Scots must not make the same fatal mistake, because:

# It is God, NOT men, Who decides who the Lawful Monarch is, and sits upon His Stone of Destiny.

King David the psalmist, whose throne the Stone of Destiny was, wrote in Psalm 2 his advice to you:2:1 Why do the unenlightened rage, and the people imagine a futile thing?

- 2:2 The kings of the earth set themselves, and the rulers take counsel together, against the "I AM", and against His Anointed, (2 Esd. 13:34) [saying],
- 2:3 Let us break Their bonds asunder, and cast away Their cords from us.
- 2:4 He that sitteth in the heavens shall laugh: the Lord shall make fools of them.
- 2:5 Then shall He speak unto them in His wrath, and terrify them in His fury.
- 2:6 Yet have I set My King (to govern <u>Isa. 9:6-7</u>) upon My Holy Hill of Gathering (<u>Isa. 33:16</u>; <u>2 Esd. 13:35</u>).
- 2:7 I will declare the decree: the "I AM" hath said unto me, Thou [art] My Son; this day have I created for thee.
- 2:8 Ask of Me, and I shall give [thee] the unenlightened [for] thine inheritance, and the uttermost parts of the earth [for] thy possession.
- 2:9 Thou shalt break them with a rod of iron; thou shalt dash them in pieces like a potter's vessel (Rev. 12:5).
- 2:10 Be wise now therefore, O ye kings: **be instructed, ye judges** of the earth.
- 2:11 Serve the "I AM" with fear, and rejoice with trembling.
- 2:12 **Kiss My Son**, lest he be angry, and ye perish [from] **The Way**, when his wrath is kindled just a little (<u>Luke</u> <u>19:27</u>). **Blessed** [are] all they that put their **trust** in **him**.

The arguable point of Law is that the legislation is fraudulent, and the pretended judges had no Lawful authority to hear this case, because the judges' alleged authority comes from QE2, Mrs Battenberg, who is not our Lawful Monarch and never has been. Her jurisdiction and the jurisdiction of the Crown, the Courts and the judges

has persistently been challenged and ignored, and the request for an independent, impartial jury has been persistently refused, as a direct result of the built-in bias in this case and others.

Mrs Dorrian should clearly not have been asked, or allowed to adjudicate in this matter, never mind lead it, because of the foregoing reason and the fact that she has ties to Brodies LLP, which, like the Parliamentary corporate body, is treated by the court as having a distinct and separate legal, not lawful personality.

Mrs Dorrian is a director of this Limited Liability
Partnership. Common-sense dictates that a person is
going to do their utmost to protect their investment. It is a
maxim in Law that no man can judge in his own cause, or
a cause to which he is a party. That clearly applies to Mrs.
Dorrian in this case.

Brodies LLP has a very lucrative contract with the Scottish Government for £40 Million pounds of taxpayers' money over four years. The Scottish Parliamentary Corporate Body started this blatant attack on the Scots campaigning for King Christ and Independence through the biblical Jubilee, and not as part of the EU.

Independence as part of the fascist Nazi-founded EU is an oxymoron/a contradiction in terms.

The battle between Christ on His Second-Coming and satan and his minions, like Elizabeth and her functionaries and supporters, has been going on for a number of years.

This life or death struggle for us, and our souls has manifested itself in this case.

This Supreme Court of Scotland comes under God's Jurisdiction, not Mrs. Battenberg's.

The SPCB deployed Brodies to attack The Stone of Destiny Camp, who in turn were deployed by God/Allah to support the Indy Camp and the struggle for true Independence and prosperity for the Scots. The real reason this was done was to attack us for our pro-Independence stance, and to cut across the appeal for the real Stone of Destiny/Coronation Stone, not the fake stone that is on display in Edinburgh Castle that Mrs. Battenberg was fraudulently crowned upon, to be brought out for JAH's Coronation as King of kings, who is Christ on his second coming, and to implement our radical policy of Independence for Scotland through Implementation of the biblical Jubilee, and not as part of the fascist, Nazi-created EU.

The fact is that Christ is here, in a new human body, that was born on 22/04/1948, EXACTLY as prophesied in the Holy Bible – <a href="http://JAHTruth.net/emmau2.htm">http://JAHTruth.net/emmau2.htm</a>.

The onus is not on us to prove to you that JAH is Christ. We have given you the evidence that proves He is.

So the onus is on you to prove that He is not.

The senators could not do it, and that's why we want to go to London.

So it follows that, as the pretended judge Mrs Dorrian is a director of a limited Liability Practice called Brodies, the conflict of interest is: not only is she getting paid from the court, funded by the government using taxpayers' money, she is also sharing in the profits of Brodies, deployed against us by the Scottish Parliamentary Corporate body.

How can it possibly be measured where Mrs Dorrian's loyalties lie, regarding how impartial she really is?

The fact that the above has been said should quite simply be enough.

A judge **must step down** in circumstances where there appears to be bias, or apparent bias.

The judicial recusal is **not then a matter of discretion**, the test for determining apparent bias is this: if a fair minded honest observer considered the facts, would conclude that there was a real possibility, that the judge is biased, **the judge must recuse himself**. See POTER v Magul (2002) 2 AC 357 at (102) that test is to be applied having regard to all the circumstances of the case.

"To maintain society's trust and confidence, justice must not only be done but be seen to be done." (<a href="https://www.lawgazette.co.uk/judicial-recusal/5038104.fullarticle">https://www.lawgazette.co.uk/judicial-recusal/5038104.fullarticle</a>)

It is quite clear what is supposedly being seen to be done, and what is actually being done are two different things.

From the start our lawful arguments have not been looked at, nor have they been considered. On the surface you have listened very politely to all the arguments from all the competing positions.

Not once have you taken the Stone of Destiny camp's message of truth and The Law into consideration in judgement. You have run from, and continue to run from, the truth and The Law.

The legal authority quoted by Brodies is not relevant to show no bias, because, Helow Vs Lord Advocate general for Scotland 2009 SC 9HL)1. This case is not relevant to Mrs Dorrian's position, because there was no Financial interest raised in this case. The leading authority quoted in this case is about the Benefits Agency and the doctors who are allegedly not biased when deciding to cut off the sick and infirm from, e.g. incapacity benefits, industrial injury disablement benefit and employment and support allowance. When applying the Clapham omnibus test here, in this case the average passenger of reasonable sound mind would agree that the doctors working for the benefits agency are clearly biased against the benefit claimants, as they have targets dictated to them by Government to impoverish further our great British Israelite nations, including The Scots (Judah-Zarah).

As I have previously pointed out, because of Mr Turnbull's granting of the Section 46 order, THE Lord of lords has entered into judgement of the princes of this land.

The prophet Mohammed, peace be upon him, said that the Christ would come again.

Christ the First said that when he returned he would come like a thief in the night.

Some of the Indy campers can bear true testimony to this, and so can this Court, as we really did enter this case like a thief in the night, carrying JAH's campaign for His Throne/ Stone.

All the way through this case you have been biased against and ignored what has been said and submitted.

From the very beginning of this case you have hardened your hearts against The Lord of lord's orders.

decide to ignore evidence and The Law that the monarch swears to maintain to the utmost of their power, that Mr. Turnbull and you ALL swore the Judge's Oath to serve.

In any case the authorities referred to by Brodies are fraudulent and of no effect, because the ONLY authority is God's Law in The Holy Bible, that the monarch swears at their coronation to maintain to the **UTMOST** of their power, especially now that Christ our Rightful and Lawful King is here again, and The Law must be glorified, as can be seen by The Lord's LAWFUL Judgement in His amicus curie brief and affidavit dated 01/08/16.

The SPCB has no lawful rights in the Sanctuary Land in question, because, as has been previously truthfully pointed out to you, with biblical proof, that it belongs to Father, Creator of the Universe, Cherisher of the Worlds, and Christ His Eldest Son, not the SPCB.

The Three judges work for the Government and therefore cannot be Impartial, because, as Mr Moynihan has previously pointed out, our position to this case to Brodies is untenable, and their position to us is untenable, because of the oath of allegiance which the fake judges swear to the fake queen Mrs Battenberg also known by the criminal alias QE2, and they are dutybound to protect her straight away from any threat they perceive to her authority, and thus their own.

For example the utterances, which Mr Steven Crielly has been charged with making, as a result of his simply quoting The Law of God in this case, to what "claims" to be a court of law, that swears on the Bible that contains that very Law, is truly Orwellian and satanic.

The Bias reflects itself in the way Steven Crielly has been

treated by this court: he has been persistently denied his say as a Scotsman in this case.

Like it or not the return of the JEDI is upon you.

Mr Alan Turnbull, like Pontius Pilate before him, washed his hands of any lawful argument and desperately clung onto pretending to listen to "legal" and thus unlawful argument about proportionality and human rights, which we are allegedly guaranteed from that great Babylonian Dictatorship of Evil known to us as the EU, from which Scotland will be freed. We are forbidden, under the Law that Elizabeth swore to maintain on her fraudulent coronation day, from being ruled by the EU.

In addition the challenge is to her Jurisdiction and Sovereignty, on the grounds that she is not the Lawful monarch and never has been.

Case reference T20107746 at Southwark

Crown Court, defendant John Anthony Hill provided irrefutable evidence before a British court, where the pretended judge, like in our case, also refused to let an independent, impartial jury decide that Elizabeth is not the Lawful Monarch and never has been, which irrefutable evidence was unlawfully ignored by the pretended judge Jeffrey Vincent Pegden, who's jurisdiction had been lawfully challenged.

This is obviously the fraudulent judges' standard operating procedure, when faced with evidence they cannot refute that proves they have no jurisdiction, and that Mrs Battenberg is not the lawful monarch.

All the paperwork we submitted has been ignored. This paperwork was delivered by hand to the court and submitted in the usual accepted manner, and also by recorded delivery. This paperwork, the affidavit of Christ The King of Scotland containing points of LAW (attached), was not in the joint appendixes. None of the evidence we supplied was in the white folders.

The points of Law raised in all the paperwork, which was submitted at least seven times, concerned the points of Law, that no one, including the pretended judges could refute. The court staff and Brodies therefore purposefully left it out of evidence, which is the crime of withholding evidence, so that they would not have to deal with the points of LAW contained in Christ's affidavits, on behalf of their employer the Government who pays their wages.

"For the wages of sin [is] DEATH; but the gift of God [is] eternal Life through Jesus Christ our Lord." (Romans 6:23)

The points of law raised, raise issues of grave public, national and world importance, which therefore must be looked at by the Supreme Court.
