Good morning and good wishes to you.

This is Tony Farrell writing.

The purpose of this email is four-fold, and as follows:

- 1. To briefly acknowledge your contribution at the Hillsborough Inquests and your devotion to serve the families you have been representing;
- 2. To remind you about Muad'Dib's Hillsborough Ripple Effect film and implore you to watch it and take heed of the message within it;
- 3. To bring to your attention an article about Hillsborough, entitled The Persistent Widow;
- 4. To impart an important message to you concerning GOD'S LAW, as opposed to "The Hillsborough Law (not law, but legislation)", which you part drafted.

I will now deal with each of these four points in turn.

## 1. YOUR CONTRIBUTION.

You will doubtless recall that after we met at the Warrington Inquests, you kindly passed on information about Walter Jackson / Andy Hymas to the Coroner's inquest team, via Tim Suter, on my behalf. Again thank-you for that. You will have then sat back and watched the subsequent cover-up and protection of Walter Jackson, when he came before Coroner Goldring a few months later. Why was there no outrage, I ask myself, rhetorically. Was my disclosure so inconsequential, that not a single lawyer dared to mention the obvious, before the corrupt Coroner Goldring, one of the many unjust judges in this whole sorry saga?

It was a huge relief to see the families get a verdict of "unlawful killing" at the inquests. It was the families, not Mrs May's Tory Government, who ensured that. What does the wretched legal system, responsible for inflicting so much misery on the families for well over a quarter of a century do in aftermath? It does no less than bask in the glory of Hillsborough, and awards its practitioners all manner of self-indulgent honours. The entire system is vile and putrid. Yes, the families of the 96, sorely needed that "unlawful killing" verdict, and the families most certainly deserved that verdict, and thankfully got it, but lawyers, however good, bad, or indifferent, they were, should not be seeking kudos from it, at least not until proper justice has been administered to the real culprits behind the disaster and its cover-up. We are still far from that, as you will see more clearly, if you read on.

I am mindful that you represent Steve Kelly and others and have, through your hard work and dealings with them, gained their respect and trust. You may or may not be aware however, that in recent days, there have been communications exchanged between Steve and I. I want to stress that neither Steve, nor any other member of the families for the 96, know that I am writing to you in this way.

Also, I have just written and released an email to your peer colleague Elkan Abrahamson. It partly, though not solely, stems from observing how your profession views itself, as borne out by this article below.

Since from now onwards, the message to impart to you, is virtually identical to the the message I have just imparted to Elkan, I am simply now going to copy and paste in the same wording. What applies to Elkan Abrahamson, applies to Peter Weatherby QC, too.

### EXTRACT FROM MY EMAIL TO ELKAN

One of my regrets was that I was unable to get to the Inquests when former ACC Walter Jackson attended, and so, I do not know to what degree you personally opposed, the Coroner's disgraceful cover-up ruling which protected the no.1 key witness from any adversarial questioning. From what had been disclosed to the family lawyers, there should have been total outrage and a walk-out when that happened. You must have known that something vital was being covered-up at that stage, in the interest of so called UK police-state national security. You, and the rest of the lawyers, allowed it to happen. I would also like to know whether or not you pressed Goldring for the fifteenth and most important question of all, which demanded being put to the jury.
