Dear David,

I hope this finds you well, in good spirit and having a good day.

You may recall that, last month, I came across to HQ, from afar, at considerable expense, just to pass over a single DVD to you, containing the Seven Hills Ripple Effect film, and two other supportive films. Deliberately, I did not share this DVD with the other usual suspects, so to speak. That DVD was private, for your eyes only, as a preview. You may recall, the next day, undeterred by the unwarranted sinister police actions taken against me on 17th September, following my previous attendance at the Hillsborough inquests, I fearlessly made a return to Birchwood, Warrington, again on business. I was pleased to see Mr. Holt there in the mid-afternoon, taking an interest in proceedings.

Continuing with the film sets, while you at one point appeared in the main Seven Hills Ripple Effect film, and you were briefly shown in another about the "Challenge" stance in the Joseph film, by and large, neither you personally, nor South Yorkshire Police in general, were the main target for the critiques. You might well have been somewhat relieved about that. If you actually watched them, you may well have felt that you got off quite lightly, and had nothing much to worry about, as the criticisms were targeting higher places of abuse of power.

However, in our second DVD in the series, which we are likewise offering to you, and you alone, for a sneak preview, the opposite is the case, as with the others in the series. In these films, the content is more directly concerned with you and the specific misconduct and misfortunes of South Yorkshire Police. With that in mind, this next DVD enclosed contains the following film.

CROMPTON EXPOSED - a critical assessment of your interviews given to Toby Foster.

This film has not gone public yet. That's been a deliberate strategy to give you time to respond positively to us. However, we plan for that to all change at some time quite soon. To continue to be as fair as possible to you, we thought that we would give you, and you alone, an opportunity to preview our second in the set of intended film unlashes, not least because you, in particular, come under the spotlight so much in them.

In fairness, we have repeatedly made polite requests of you to meet with us, to discuss a range of very important related issues. These issues are referred to in the film series. Historically, to our dismay, never once have we been given the courtesy of a reply, to our polite and respectful requests. As you no doubt appreciate, the issues we raise with you are non-trivial. It is not denied that occasionally, you do communicate with me, but invariably you avoid dealing with the burning questions which we pose. I have showed great patience and perseverance in an effort to help you and SYP. That is not moaning. I am just pointing out the obvious.

My suggestion from hereon in is simple. First, I invite you to watch the film on the second DVD and also, if you can spare the time, re-watch the Seven Hills Ripple Effect film. The film on my second DVD will probably be the one which will cause you the most personal discomfort, so far. Second, once you have had time to reflect upon our analysis of your position, then we would like you to consider our repeated request to meet up for a frank discussion. Our offer to help you remains genuine. We and God want you to become a force for good/God. You placed yourself in what you must have surely realised from the very start, was always going to be one of the most demanding and thankless jobs around. I asked you why you took up the poisoned chalice and you philosophically said, somebody had to take it.

We do not underestimate the challenges you face as a Chief Constable of a much maligned and corrupt police force. I did not work for 17 years in my position without learning one or two things about police culture, and group dynamics, in the organisation that you now lead. Furthermore, nobody knows better than JAH, the stranglehold that dark elements have in police circles via ACPO, Freemasonry and its Luciferian esoteric roots (Albert Pike's "Morals and Dogma" and WW3). If ever strong leadership is needed, it is now. Our suggestion is that you, having watched the films, and read "The Way home or face The Fire" - <http://thewayhomeorfacethefire.net> - agree to meet with JAH and myself for an hour or so. We would be happy to do this in normal business hours, or alternatively meet somewhere less formally in Sheffield or elsewhere, in the evening, or weekend. We are not seeking to trick you in any way. On the contrary, we are trying to help you.

I want to end this letter on a personal note, which partly explains why I got called out from the police back in 2010. I have no doubt now that it was to fulfill a prophetic type ministry. My calling started well before 2010. If you read my "Little London Letter", my "Rich Picture of an Ignoble Lie or Enabling the One Truth" dismissal report, or indeed my Religious Philosophical Belief Statement that went before the Sheffield Tribunal, you will be aware that from very early on, before I knew about you, or JAH for that matter, and well before I got the sack, there was a spiritual dimension to this mutual struggle, in which we are embroiled.

You may not have realised it yet, but you personally are playing out a key role of truly biblical proportions here. I am here to tell you that fact, and surely, all the ongoing date synchronizations can't have escaped your notice, and the notice of some other members of your Senior Command Team.

Obviously, you have a free will, and I know for sure that God is calling you out to do something very special indeed. You are, of course, at liberty to keep ignoring God's calling and instead continue to listen to the voice of Satan inside your head. Being disobedient to God's call, must be easy to do when surrounded, as you will undoubtedly be, in your ACPO quarters, by strong Masonic Luciferian influences. JAH, Himself, has already written to you once explaining the curse that has befallen South Yorkshire Police. Do you not realise how God's work is at hand in all of this?

For my part, yesterday, I had a dream in which you again featured. I will be writing a separate letter to Dr. Alan Billings, but I will not be disclosing details of the "Crompton Exposed" film, as shown on our second DVD to you, at least not at this stage. We will however pass on to the new Police and Crime Commissioner, a copy of the Seven Hills Ripple Effect film and invite him also to watch "Seven in Barnsley", as that particular film features the inaction of his predecessor Shaun Wright and our highly pertinent shofar activities conducted outside the Commissioner's offices, at Regent Street, back on 5th July 2013.

Sight of these activities, which are of a biblical nature, asking God to bring down the walls of silence covering up corruption, should serve as a stark message to him and strike a chord with a man who already professes, in public,

to love God. He professed that, by his utterances about a city's welfare as quoted from the Old Testament major prophet Jeremiah, in the pre-election debate between the four candidates before a public audience.
