***I acknowledge receipt of your email this morning and your apology over the Cliff-gate incident.***

***Thank-you.***

***Notwithstanding my appeal to the IPCC about your earlier decision regarding the Clegg-gate eviction, I was somewhat saddened to learn from you, that had you seen my second email earlier, you would still have declined to meet with me to discuss my complaint against my arrest and charge.***

***So be it. As you appreciate, it has now passed into the hands of the IPCC. Should the IPCC ultimately request SYP to make a formal review of my case, then I would expect that the IPCC / SYP would allocate the case to someone other than you.***

***Actually, if I may offer my opinion here, you have turned down an opportunity to engage your force in a very pertinent issue that transcends way beyond the relatively trivial matter of an eviction and arrest and charge of resisting a bailiff. With reference to the content within my bundle of evidence, you don't come across intelligence like this every day. I am uncertain whether you appreciate that fact. That said, I'll wait patiently and see what the IPCC make of it all.***

*So that you have a better understanding of where I was coming from on this, I am forwarding on to you an email I sent to JAH /Muad' Dib on Monday where David Crompton, Andy Holt and Nigel Hiller all got copied-in. The email touched on the Cliff Richards incident in Berkshire, but as you may see from its content if you read it properly, I was not antagonistic towards South Yorkshire Police. On the contrary, I was trying to help them do what's right as wider police corruption is out of control, and my sincere hope is that South Yorkshire Police do become the best force in the country, but to attain that position, they will have to make some really tough decisions and your role will be a pivotal one that has to become squeaky clean. I am far from convinced it is at the moment. Your priority must be to objectively elicit the truth behind the merits of complaints, not to suppress complaints at any cost. You should look on complaints like mine as gifts and opportunities to improve the service and stamp out corruption.*

*Anyway, enough said for now. Feel free to read this below if you wish. You might get a surprise.*

*Dear Lord,*

*Good morning and good wishes.*

*As controversy grows over the CLIFF-GATE story, I have just discovered that Dan Johnson from the BBC was covering the on-scene action in Berkshire. Please see link below. You will recall that Dan Johnson spoke to me during my 12-hour vigil outside Carbrook Hall Police HQ on 2nd September 2013.*

*That's the day when I first met David Crompton. Back then on the third anniversary of my dismissal, Dan was reporting for the BBC local news programme Look North on a £14:53 "coppers-on-the-pitch" issue associated with the Hillsborough disaster.*

*You will recall that the incident related well with the "God cares about honesty in the workplace" theme which I experienced on the day I got sacked (2<sup>nd</sup> September 2010) and on 6th July 2013 (three years after I first stuck my head above the parapet) when I found the police officer's wallet and warrant card on a sports-field near the Arena while actually on the way to Snig Hill and the Hillsborough stadium to blow the shofar.*

*You will also recall that following the Chief Constable's talk at the Greystones Pub on 4th February 2014, my long letter to David Crompton touched on that very same theme of "God cares about honesty in the workplace" and it mentioned the strange encounter I had on that "vigil day" with the BBC Local News Reporter, Dan Johnson. It's interesting that Dan should again feature at this moment in time.*

*Sadly, David Crompton has so far remained mute over my recent request for us to meet together prior to the release of our ripple effect film and new website. I am somewhat surprised that he has not at least given us a straight yes or no answer to my polite email request. Perhaps, he is still considering it, although I think he's on annual leave until next week. I am sure they will be curious as to what I'll do next but I'm not so sure that Senior Command Team fully appreciate that we are actually trying to help them, despite everything.*

*It's early days here, but it seems to me that South Yorkshire Police have taken a bold step for a change and irrespective of the legal rights and wrongs of their actions and communications with the BBC, I take the view that this is the first obviously positive sign and courageous decision they've made at the top for a considerable amount of time. As you know, Cliff Richards may be linked to the Elm Guest House and intelligence suggests he may have been spending time with Gill Dando just before her assassination and the subsequent police-state cover-up of the real killer which plainly wasn't Barry George. David Crompton may have views on that given his ACPO portfolio on Homicide Investigation and that may have influenced his decision making.*

*I note that the famous BBC celebrity from Barnsley, Michael Parkinson has tried to put the boot in over the actions of the police. Again this resonates well with "Barnsley Boot Boys Rule OK" theme in our extra surplus module on the "Unlawful Killing" film which we shared with David Crompton as shown before our team's visit to Barnsley last year just after Ms. Seven handed in the joint report about her case.*

*I am copying David Crompton, Andy Holt and Nigel Hiller into this email in the hope that the Chief Constable will be courteous enough to give me a reply to my request for a meeting, either way.*
